

# Reese's Shop Double Dutch Team Captain Agreement

*Initial*

- \_\_\_\_ 1. TC understands that TC is an Independent Contractor and is not an employee of Reese's Shop and Reese's Shop shall never be held responsible for TC's actions.
- \_\_\_\_ 2. TC is responsible to market/advertise approved marketing and advertising materials by Reese's Shop as TC sees fit on a daily bases online & offline to bring on new team members. TC is compensated \$5 per new member that TC recruited and will be 1099'd at the end of each year.
- \_\_\_\_ 3. Starting October, 2025, TC agrees to attend all Reese's Shop fixed training sessions to train members. These locations, days & times are as followed & are subject to change with notice:  
    *Wednesday: Reese's Shop Day: Walmart Parking lot in Titusville, FL from 4pm to 9pm*  
    *Thursday: Reese's Shop Day: Walmart Parking lot in Merritt Island, FL from 4pm to 9pm*  
    *Friday: Reese's Shop Day: Walmart Parking lot in Cocoa, FL from 4pm to 9pm*

Starting now until October 2025, TC agrees to focus on building his/her team while providing training using the Progress Report, on the following days at any public park: *(Any days you will not have a training session, simply put Off). (Reese's Shop training session locations are subject to change)*
